PRICING:

Refer to the V29 "State of Arkansas" price list from ESI.

ORDERING:

Forward the State of Arkansas contract purchase order by email to orders@esiergo.com.

SHIPPING:

Freight is included on products totaling at least \$100 (except tables). For standard orders totaling under \$100 net, a \$14.99 flat rate shipping fee will be charged. Please review our freight policy below. Specify **ship to** address. We can direct-ship to the dealer's address or drop ship to the end user's location (anywhere within the contiguous 48 states). Orders ship within 48 hours from receipt of PO.

Packages should be inspected upon receipt and any shortages must be conveyed within five (5) business days of delivery. We are not responsible for damages or shortages occurring after delivery. Additional shipping charges will apply for expedited shipping, inside delivery or lift gate services. We are happy to drop ship to any customer within the 48 contiguous United States at no extra charge.
